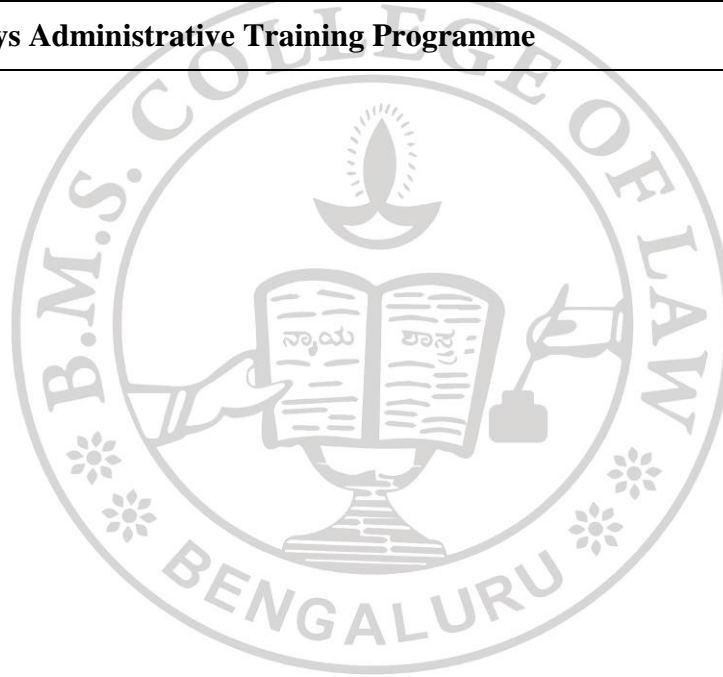

REPORT ON FACULTY DEVELOPMENT PROGRAMME-2023

New Teaching Pedagogy in Legal Education – Seven-days Faculty Development Programme was organized from 30 August to 6 September 2023. It hosted various academicians and experts from multi-disciplinary backgrounds who shared their experiences. The programme was designed to craft the ways and means of delivering domain-specific knowledge, improve the teaching-learning Pedagogy and make teaching staff share their experiences about classroom teaching methods. The objectives were to create awareness on:

1. Teaching Approaches
2. Stress Management & Emotional Intelligence
3. Team Building
4. Contemporary Developments in Law
5. Usage of ICT Tools
6. Professional Ethics & Code of Conduct
7. Legal Research Methodology

Day 1: Inauguration & Session on ‘Approach to Teaching Interpretation of Statutes’

The day began with a Welcome address and an Introduction to the resource person,

Sri. Vishnu Prasad, Associate Professor, KLE Society’s Law College, Bengaluru. He engaged in an interesting session on various training tools and methods for teaching a course in the Interpretation of Statutes. He also suggested certain ideas about learning resources such as cardinal books, research papers and online databases which are highly recommended for teachers as well as students. It was pointed out that the primary importance should be accorded to effective lectures and its learned preparation by all the faculty members. It was suggested to uncover the course syllabus by informing students about course objectives, outcomes, and skills to be learned at the completion of that course. He also insisted on bringing in different synergies in classroom discussions by assigning different problem-solving tasks to students. The session came to an end with interaction through Q&A and a vote of thanks.

Day 2: Session on Stress Management and Emotional Intelligence

Smt. Sushma Lingaraj, Counselor, Dayanand Sagar Institutions, Bengaluru held an extensive session on living a life happily without running down into depression. She spoke about specific tools to mitigate effects of burnout and anxiety. She advised faculty members to practice positive affirmations and meditation so that emotional intelligence can be applied in daily professional life and personal life balance. This particular session saw participation by each faculty participants to come across and sharing their life struggle story. It was concluded with a very positive note that mental well-being is achievable easily.

Day 3: Session on Teamwork and Team building

A session was conducted by Ms. Praveena Shivkumar, Counselor, Dayanand Sagar Institutions, Bengaluru by presenting a detailed purpose of a formation of team and leadership. She divided the faculty participants into groups and assigned a task in which each team had to pass-on a ball using their feet; which was observed with great sportive spirit. It was again told that two participants in each team had to play unleashing a knot activity which taught a problem solving as a teammates. Later, each of participants were asked to fill-in personality test questionnaire. After solving the questionnaire, all of them were able to determine their personality type and various traits. A session was concluded with a positive message that if anybody wants to improve a personality; should work on the skills.

Day 4: Session on Contemporary Legal Facets

A session was held by Prof. Subhas Goudappanavar, Associate Professor, KLE Society's Law College, Bengaluru who presented various contemporary developments in law and legal academia. He asked every faculty participant to practice traditional method of teaching which includes eye to eye contact with students, intensive use of chalk and talk method and case studies. He talked about methods of teaching subjects like criminal laws, constitutional law and interpretation of statutes. He greatly insisted that every law faculty should teach jurisprudence at least once, so that essential legal reasoning is produced and then shared among law students too. He concluded by suggesting a future way to make classrooms more engaging is the teacher's ability to interact with the students on the basis of domain knowledge and great inter-personal communication skills.

Day 5: Session on Usage of Excel in Academia

A session was held by Smt. Divyashree B Rao, Assistant Professor, BMSCW, Bengaluru who is an expert in computing. Each of faculty participants were provided with a desktop to have hands-on practical session with the resource person. It included making use of MS Office – Excel in daily professional assignments such as preparing worksheets, calculating attendance, use of shortcuts, formulae and so on. Faculty participants were benefited widely by practicing the sheets and resolving their queries from the resource person.

Day 6: Session on Professional Ethics & Code of Conduct

Sri. Trivikram S S, Advocate, Bengaluru conducted an interactive session on professional ethics in teaching profession wherein he pointed towards certain mishappenings in the fraternity. He opined that for a healthy student-teacher bond and institutional development, it is so required to adhere to ethical and moral code of conduct. He also reflected upon research and publication ethics to which faculty participants always subscribes to. He provided a detailed presentation on modes of adhering to code of conduct by faculty members.

Day 7: Session on Legal Research and Teaching

Prof. (Dr.) M K Ramesh, NLSIU, Bangalore engaged all the faculty participants meticulously by making it an interactive communication over teaching a law students. He wished everyone and shared the greetings of Teacher's Day and also shared his wide experience with all the faculty participants. He essentially insisted on the fact that teachers are always a role model for his students and thus every teacher has give the best of knowledge to pupils. Research which is an inseparable part an academia should come through naturally, he expressed. All the participants thanked him for his gracious presence and training.


