### Report of the Class Representatives for Even Semester of the Academic Year 2023-24

With an object to collect constructive feedback to strengthen the quality of teaching-learning environment and to look for opportunities to improve and bring excellence in teaching and learning in the institution, Goggle form in the nature of feedback was released to all the Class representatives of 3 year LL.B., 5 Year B.A., LL.B. and 5 Year B.Com. LL.B. feedback was collected on various parameters including Planning and Preparation for the class, Use of teaching aids, allotment of IA Topics, class room mechanism and regularity and punctuality of course teachers.
